A partial amendment of the rules was approved by the Society's Board of Directors, in terms of Rule 13.2, on 24 September 2016 to meet the requirements of Charities Services. This involved the addition of new rule 12.9 Branches and Interest Groups registered as Charities. The amendment was registered by the Registrar of Incorporated Societies on 28 September 2016.

Rule 12.9 is quoted below. A full version of the Rules may be accessed on the NZSG website. Our group is required to hold an extra ordinary general meeting to approve and adopt Rule 12.9.

12.9 Branches and Interest Groups Registered as Charities

A Branch or Interest Group operating as an unincorporated group, and registered as a charity, must ensure that:

- a) any income, benefit, or advantage must be used to advance the charitable purposes of the Branch or Interest Group;
- no member of the Branch or Interest Group, or anyone associated with a member, is allowed to take part in, or influence any decision made by the Branch or Interest Group in respect of payments to, or on behalf of, the member or associated person of any income, benefit, or advantage;

c) any payments made to a member of the Branch or Interest Group, or person associated with a Branch or Interest Group, must be for goods or services that advance the charitable purpose and must be reasonable and relative to payments that would be made between unrelated parties.
